PREFACE

CONSTITUTIONAL DECLARATION

WHEREAS, It is the express purpose of God, our heavenly Father, to call out of the world, a saved people, who shall constitute the body or church of Jesus Christ, built and established upon the foundation of the apostles and prophets, Jesus Christ Himself being the chief cornerstone; and

WHEREAS, The members of the body, the church (ecclesia) of Jesus Christ, are enjoined to assemble themselves together for worship, fellowship, counsel and instruction in the Word of God and the work of the ministry and for the exercise of those spiritual gifts and offices provided for in the New Testament; and

WHEREAS, It is evident that the first century churches came together in such fellowship as a representative body of saved, Spirit-filled believers, who ordained and sent out apostles, prophets, and evangelists, and who under the supervision of the Holy Spirit, set over the church pastors and teachers, and

WHEREAS, the Kansas Network Council of the Assemblies of God, Inc. is an organism consisting of member churches and credential holders, and as such, represents a diverse expression of the church within the boundaries of the state of Kansas, and

WHEREAS, this diverse expression of the church, under spiritually discerning leadership must address the major elements that promote health in every aspect of the body of Christ with these elements functioning in balance and anointing of the Spirit to produce effective Pentecostal leaders and churches that affect the world, Therefore, be it

Resolved, That we recognize ourselves as a cooperative fellowship of Pentecostal assemblies of like precious faith throughout the United States and the world, to be known as the General Council of the Assemblies of God, whose purpose is not to usurp authority over the various local assemblies, nor to deprive them of their scriptural and local rights and privileges, but to recognize and promote scriptural methods and order for worship, unity, fellowship, work and business for God; and to disapprove un-scriptural methods, doctrines and conduct, "endeavoring to keep the unity of the Spirit in the bond of peace, till we all come in the unity of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ" (Eph. 4:13).

NETWORK CONSTITUTION

Preamble: For the purpose of promulgating the gospel of Jesus Christ by all available means in our Network, so that the results of our efforts may be conserved and assemblies established and developed in general unity and cooperative fellowship along the lines of our distinctive testimony; and for the further purpose of cooperating with all other like Networks in the work of the General Council at home and abroad; we, who are members of the General Council of the Assemblies of God, hereby associate ourselves as Network Council of the Assemblies of God, and agree to be governed by the following constitution and bylaws.

ARTICLE I. NAME

The name of this body shall be The Kansas Network Council of the Assemblies of God Inc., (and may also function as the Assemblies of God Kansas (AGK) Ministry Network).

ARTICLE II. TERRITORY

This Network shall include the work of the Assemblies of God in the state of Kansas.

ARTICLE III. PREROGATIVES

In connection with its purpose to promulgate the gospel of Jesus Christ at home and abroad by all available means, this Network Council shall have the following rights:

- 1. To supervise all activities of the Assemblies of God within its boundaries, except such as shall be agreed upon by the Network Council and the General Council officials.
- 2. To examine, approve and recommend candidates to the General Council who have met the requirements of the Network as set forth in its constitution and bylaws as certified ministers, licensed ministers and ordained ministers.
- 3. General Council in matters of doctrine and the conduct of all ministers who are permitted to have Network endorsement.
- 4. To establish churches and to provide for their development, and to establish and maintain such departments, ministries and initiatives for the fellowship as may be necessary for the propagation of the gospel.
- 5. To own, to hold in trust, use, sell, convey, mortgage, lease or otherwise dispose of such property, real or chattel, as may be needed for the prosecution of its work.
- 6. To create, establish and fund departments, ministries, and initiatives as deemed necessary.

ARTICLE IV. STATEMENT OF FUNDAMENTAL TRUTHS

The Bible is our all-sufficient rule for faith and practice. This Statement of Fundamental Truths is intended simply as a basis of fellowship among us (i.e., that we all speak the same thing, 1 Cor. 1:10; Acts 2:42). The phraseology employed in this statement is not inspired or contended for, but the truth set forth is held to be essential to a full-gospel ministry. No claim is made that it contains all biblical truth, only that it covers our need as to these fundamental doctrines.

1. The Scriptures Inspired

The Scriptures, both Old and New Testaments, are verbally in spired of God and are the revelation of God to man, the infallible, authoritative rule of faith and conduct (2 Tim. 3:15-17; 1 Thess. 2:13; 2 Peter 1:21).

2. The One True God

The one true God has revealed Himself as the eternally self-existent "I AM," the Creator of heaven and earth and the Redeemer of mankind. He has further revealed Himself as embodying the principles of relationship and association as Father, Son and Holy Ghost (Deut. 6:4; Isa. 43:10-11; Matt. 28:19; Luke 3:22).

THE ADORABLE GODHEAD

(a) Terms Defined

The terms "trinity" and "persons," as related to the Godhead, while not found in the Scriptures, are words in harmony with Scripture, whereby we may convey to others our immediate understanding of the doctrine of Christ respecting the being of God, as distinguished from "gods many and lords many." We therefore may speak with propriety of the Lord our God, who is One Lord, as a trinity or as one Being of three persons, and still be absolutely scriptural (examples, Matt. 28:19; 2 Cor. 13:14; John 14:16-17).

(b) Distinction and Relationship in the Godhead

Christ taught a distinction of persons in the Godhead which He expressed in specific terms of relationship, as Father, Son and Holy Ghost, but that this distinction and relationship, as to its mode is inscrutable and incomprehensible, because unexplained (Luke 1:35; 1 Cor. 1:24; Matt. 11:25-27; 28:19; 2 Cor. 13:14; 1 John 1:3-4).

(c) Unity of the One Being of Father, Son and Holy Ghost

Accordingly, therefore, there is that in the Son which constitutes Him the Son and not the Father, and there is that in the Holy Ghost which constitutes him the Holy Ghost and not either the Father or the Son. Wherefore, the Father is the begetter, the Son is the begotten; and the Holy Ghost is the one proceeding from the Father and the Son. Therefore, because these three persons in the Godhead are in a state of unity, there is but one Lord God Almighty and His name is one (John 1:18; 15:26; 17:11, 21; Zech. 14:9).

(d) Identity and Cooperation in the Godhead

The Father, the Son and the Holy Ghost are never identical as to person nor confused as to relation; nor divided in respect to the Godhead; nor opposed as to cooperation. The Son is in the Father and the Father is in the Son as to relationship. The Son is with the Father and the Father is with the Son, as to fellowship. The Father is not from the Son, but the Son is from the Father, as to authority. The Holy Ghost is from the Father and the Son proceeding as to nature, relationship, cooperation and authority. Hence, no person in the Godhead either exists or works separately or independently of the others (John 5:17-30, 32, 37; John 8:17-18).

(e) The Title, Lord Jesus Christ

The appellation, "Lord Jesus Christ," is a proper name. It is never applied, in the New Testament, either to the Father or to the Holy Ghost, it therefore belongs exclusively to the Son of God (Rom.1:1-37; 2 John 3).

(f) The Lord Jesus Christ, God with Us

The Lord Jesus Christ, as to His divine and eternal nature, is the proper and only begotten of the Father but as to His human nature, He is the proper Son of Man. He is, therefore, acknowledged to be both God and man; who because He is God and man is "Immanuel," God with us (Matt. 1:23; 1 John 4:2, 10, 14; Rev. 1:13, 17).

(g) The Title, Son of God

Since the name "Immanuel" embraces both God and man in the one person, our Lord Jesus Christ, it follows that the title, Son of God, describes His proper deity, and the title, Son of Man, His proper humanity. Therefore, the title, Son of God belongs to the order of eternity, and the title, Son of Man, to the order of time (Matt. 1:21-23; 2 John 3; 1 John 3:8; Heb. 7:3; 1:1-13).

(h) Transgression of the Doctrine of Christ

Wherefore, it is a transgression of the doctrine of Christ to say that Jesus Christ derived the title, Son of God, solely from the fact of the incarnation, or because of His relation to the economy of redemption. Therefore, to deny that the Father is a real and eternal Father, and that the Son is a real and eternal Son, is a denial of the distinction and relationship in the being of God; a denial of the Father and the Son; and a displacement of the truth that Jesus Christ is come in the flesh (2 John 9; John 1:1-2, 14, 18, 29, 49; 1 John 2:22-23; 4:1-5; Heb. 12:2).

(i) Exaltation of Jesus Christ as Lord

The Son of God, our Lord Jesus Christ, having by Himself purged our sins, sat down on the right hand of the Majesty on high; angels and principalities and powers having been made subject unto Him. And having been made both Lord and Christ, He sent the Holy Ghost that we, in the name of Jesus, might bow our knees and confess that Jesus Christ is Lord to the glory of God the Father until the end, when the Son shall become subject to the Father that God may be all in all (Heb. 1:3; 1 Peter 3:22; Acts 2:32-36; Rom. 14:11; 1 Cor. 15:24-28).

(i) Equal Honor to the Father and the Son

Wherefore, since the Father has delivered all judgment unto the Son, it is not only the express duty of all in heaven and on earth to bow the knee, but it is an unspeakable joy in the Holy Ghost to ascribe unto the Son all the attributes of deity, and to give Him all the honor and the glory contained in all the names and titles of the Godhead except those which express relationship (see Paragraphs b, c and d), and thus honor the Son even as we honor the Father (John 5:22-23; 1 Peter 1:8; Rev. 5:6-14; Phil. 2:8-9; Rev. 7:9-10; 4:8-11).

3. The Deity of the Lord Jesus Christ

The Lord Jesus Christ is the eternal Son of God. The Scriptures declare:

- (a) His virgin birth (Matt. 1:23; Luke 1:31, 35).
- (b) His sinless life (Heb. 7:26; 1 Peter 2:22).
- (c) His miracles (Acts 2:22; 10:38).
- (d) His substitutionary work on the cross (1 Cor. 15:3; 2 Cor. 5:21).
- (e) His bodily resurrection from the dead (Matt. 28:6; Luke 24:39; 1 Cor. 15:4).
- (f) His exaltation to the right hand of God (Acts 1:9, 11; 2:33; Phil. 2:9-11; Heb. 1:3).

4. The Fall of Man

Man was created good and upright; for God said, "Let us make man in our image, after our likeness." However, man by voluntary transgression fell and thereby incurred not only physical death but also spiritual death, which is separation from God (Gen. 1:26-27; 2:17; 3:6; Rom. 5:12-19).

5. Salvation of Man

Man's only hope of redemption is through the shed blood of Jesus Christ the Son of God.

(a) Conditions to Salvation

Salvation is received through repentance toward God and faith toward the Lord Jesus Christ. By the washing of regeneration and renewing of the Holy Ghost, being justified by grace through faith, man becomes an heir of God according to the hope of eternal life (Luke 24:47; John 3:3; Rom. 10:13-15; Eph. 2:8; Titus 2:11; 3:5-7).

(b) The Evidence of Salvation

The inward evidence of salvation is the direct witness of the Spirit (Rom. 8:16). The outward evidence to all men is a life of righteousness and true holiness (Eph. 4:24; Titus 2:12).

6. The Ordinances of the Church

(a) Baptism in Water

The ordinance of baptism by immersion is commanded in the Scriptures. All who repent and believe in Christ as Saviour and Lord are to be baptized. Thus they declare to the world that they have died with Christ and that they also have been raised with Him to walk in newness of life (Matt. 28:19; Mark 16:16; Acts 10:47-48; Rom. 6:4).

(b) Holy Communion

The Lord's Supper, consisting of the elements — bread and the fruit of the vine — is the symbol expressing our sharing the divine nature of our Lord Jesus Christ (2 Peter 1:4); a memorial of His suffering and death (1 Cor. 11:26); and a prophecy of His second coming (1 Cor. 11:26); and is enjoined on all believers "till He come."

7. The Baptism in the Holy Ghost

All believers are entitled to and should ardently expect and earnestly seek the promise of the Father, the baptism in the Holy Ghost and fire, according to the command of our Lord Jesus Christ. This was the normal experience of all in the early Christian church. With it comes the enduement of power for life and service, the bestowment of the gift and their uses in the work of the ministry (Luke 24:49; Acts 1:4, 8; 1 Cor. 12:1-31). This experience is distinct from and subsequent to the experience of the new birth (Acts 8:12-17; 10:44-46; 11:14-16; 15:7-9). With the baptism in the Holy Ghost come such experiences as an overflowing fullness of the Spirit (John 7:37-39; Acts 4:8), a deepened reverence for God (Acts 2:43; Heb. 12:28), an intensified consecration to God and dedication to His work (Acts 2:42), and a more active love for Christ, for His Word and for the lost (Mark 16:20).

8. The Evidence of the Baptism in the Holy Ghost

The baptism of believers in the Holy Ghost is witnessed by the initial physical sign of speaking with other tongues as the Spirit of God gives them utterance (Acts 2:4). The speaking in tongues in this instance is the same in essence as the gift of tongues (1 Cor. 12:4-10, 28), but different in purpose and use.

9. Sanctification

Sanctification is an act of separation from that which is evil, and of dedication unto God (Rom. 12:1-2; 1 Thess. 5:23; Heb. 13:12). The Scriptures teach a life of "holiness without which no man shall see the Lord" (Heb. 12:14). By the power of the Holy Ghost we are able to obey the command, "Be ye holy, for I am holy" (1 Peter 1:15-16).

Sanctification is realized in the believer by recognizing our individual identification with Christ in His death and resurrection, and by faith reckoning daily upon the fact of that union, and by offering every faculty continually to the dominion of the Holy Spirit (Rom. 6:1-11, 13; Rom. 8:1-2, 13; Gal. 2:20; Phil. 2:12-13; 1 Peter 1:5).

10. The Church and Its Mission

The church is the body of Christ, the habitation of God through the Spirit, with divine appointments for the fulfillment of her great commission. Each believer, born of the Spirit, is an integral part of the general assembly and church of the firstborn, which are written in heaven (Eph. 1:22-23; 2:22; Heb. 12:23).

Since God's purpose concerning man is to seek and to save that which is lost, to be worshiped by man, and to build a body of believers in the image of His Son, the priority reason-for-being of the Assemblies of God as part of the church is:

- (a) To be an agency of God for evangelizing the world (Acts 1:8; Matt. 28:19-20; Mark 16:15-16).
- (b) To be a corporate body in which man may worship God (1 Cor. 12:13).
- (c) To be a channel of God's purpose to build a body of saints being perfected in the image of His Son (Eph. 4:11-16; 1 Cor. 12:28; 1 Cor. 14:12).
- (d) To be a people who demonstrate God's love and compassion for all the world (Psalm 112:9; Galatians 2:10; 6:10; James 1:27)

The Assemblies of God exists expressly to give continuing emphasis to this reason-for-being in the New Testament apostolic pattern by teaching and encouraging believers to be baptized in the Holy Spirit. This experience:

- (a) Enables them to evangelize in the power of the Spirit with accompanying supernatural signs (Mark 16:15-20; Acts 4:29-31; Heb. 2:3-4).
- (b) Adds a necessary dimension to a worshipful relationship with God (1 Cor. 2:10-16; 1 Cor. 12-14).
- (c) Enables them to respond to the full working of the Holy Spirit in expression of fruit and gifts and ministries as in New Testament times for the edifying of the body of Christ (Gal. 5:22-26; 1 Cor. 14:12; Eph. 4:11-12; 1 Cor. 12:28; Col. 1:29).

11. The Ministry

A divinely called and scripturally ordained ministry has been provided by our Lord for the fourfold purpose of leading the Church in: (1) evangelization of the world (Mark 16:15-20); (2) worship of God (John 4:23-24); and (3) building a body of saints being perfected in the image of His Son (Eph. 4:11-16), and (4) meeting human need with ministries of love and compassion (Psalm 112:9; Galatians 2:10; 6:10; James 1:27).

12. Divine Healing

Divine healing is an integral part of the gospel. Deliverance from sickness is provided for in the atonement, and is the privilege of all believers (Isa. 53:4-5; Matt. 8:16-17; James 5:14-16).

13. The Blessed Hope

The resurrection of those who have fallen asleep in Christ and their translation together with those who are alive and remain unto the coming of the Lord is the imminent and blessed hope of the Church (1 Thess. 4:16-17; Rom. 8:23; Titus 2:13; 1 Cor. 15:51-52).

14. The Millennial Reign of Christ

The second coming of Christ includes the rapture of the saints, which is our blessed hope, followed by the visible return of Christ with His saints to reign on the earth for 1,000 years (Zech. 14:5; Matt. 24:27, 30; Rev. 1:7; 19:11-14; 20:1-6). This millennial reign will bring the salvation of national Israel (Ezek. 37:21-22; Zeph. 3:19-20; Rom. 11:26-27) and the establishment of universal peace (Isa. 11:6-9; Ps. 72:3-8; Micah 4:3-4).

15. The Final Judgment

There will be a final judgment in which the wicked dead will be raised and judged according to their works. Whosoever is not found written in the Book of Life, together with the devil and his angels, the beast and the false prophet, will be consigned to everlasting punishment in the lake which burns with fire and brim-stone, which is the second death (Rev. 19:20; 20:11-15; 21:8; Matt. 25:46; Mark 9:43-48).

16. The New Heavens and the New Earth

We, "according to His promise, look for new heavens and a new earth wherein dwelleth righteousness" (2 Peter 3:13; Rev. 21:22).

ARTICLE V. ASSEMBLIES OF GOD POSITION PAPERS

In all matters not explicitly addressed in the Statement of Fundamental Truths, the Kansas Network Council of the Assemblies of God aligns itself with the official Position Papers of the General Council of the Assemblies of God.

ARTICLE V. RELATIONSHIP

- 1. The Kansas Network Council of the Assemblies of God Inc., (AGK) shall recognize itself as a part of the General Council of the Assemblies of God, whose national office is in Springfield, Missouri, and shall recognize and be subject to the said General Council as the parent body.
- 2. The local churches of the Network, which are in full fellowship with the Network, shall recognize and be subject to the Network Council as set forth in Article IX.
- 3. The leadership structure of the Network Council exists to strengthen and establish effective Pentecostal leaders and churches with reciprocation by the local churches and leaders expressing mutual support between themselves and the unified church known as the AGK.

ARTICLE VI. MEMBERSHIP

Membership of the Kansas Network Council shall consist of:

- 1. All ministers holding accredited fellowship certificates from the General Council and having their permanent residence within the State of Kansas.
- 2. Senior retired ministers having their residence within the state of Kansas, or if living in another state choosing to be affiliated with the Kansas Network.
- 3. Ministers affiliated with the Kansas Network but presently associated with national headquarters or Bible schools may retain their membership in the Kansas Network.
- 4. Students attending Bible schools or colleges should retain their membership in their home Network until permanently located.

ARTICLE VII. MEETINGS

- 1. The Network Council shall meet annually, the time and place to be decided by the Board of Directors. Announcement shall be published not later than one month before the meeting.
- 2. Special sessions may be called to meet any emergency that may arise within the Network. Such call should be issued by the Superintendent or the Secretary/Treasurer after the emergency has been fully considered and passed upon by a majority vote of the Board of Directors.
- 3. Special sessions to fill vacancies in the offices shall be called as prescribed for in the bylaws.

ARTICLE VIII. LEADERSHIP

Section 1. Executives

- A. There shall be a Superintendent, an Assistant Superintendent, and a Secretary/Treasurer of the Kansas Network Council Inc., (AGK) who shall be its executives, and shall be elected and perform duties as described in the bylaws.
- B. They shall have the general oversight of the activities of the Network and they shall be empowered to act in emergency matters in the interim between meetings of the Board of Directors.

Section 2. Presbyters

The presbyter shall be elected and perform duties as described in the bylaws, and, by virtue of office, be a member of the board of directors.

Section 3. Network Boards

- A. Board of Directors
 - 1. There shall be a Board of Directors.
 - 2. The Board of Directors shall be the duly authorized agency responsible for the general oversight and administration of the Network in the interim between Council sessions.
 - 3. The Board of Directors shall consist of the Superintendent, Assistant Superintendent, Secretary/Treasurer, and presbyters.
 - 4. The Board of Directors shall be authorized to act for the Network Council in all emergency matters that affect the interests of the Network Council and to execute board decisions. In such matters, such decisions shall be final unless reversed by the Council in session.
- B. Board of Trustees
 - 1. There shall be a Board of Trustees consisting of the Superintendent, Assistant Superintendent, and Secretary/Treasurer.
 - 2. All property of the Kansas Network Council of the Assemblies of God Inc., (AGK) both real and chattel, shall be committed to their safekeeping.
 - 3. They shall be the Council's officers who are designated to sign, execute and deliver, in the name and on behalf of the corporation, all legal documents, and the Secretary/Treasurer shall certify in such instrument of conveyance that the same has been duly recommended and authorized.

ARTICLE IX. LOCAL ASSEMBLIES

Section 1. Rights Related to Self-Government

- A. General Council-Affiliated Churches
 - 1. We recognize that each local assembly has the right of self-government under Jesus Christ, its living head.
 - 2. The local assembly shall have the power to choose its pastor, elects its official board and transact all other business pertaining to its life as a local assembly.

- 3. The local assembly shall have the right to administer discipline to its members according to the Scriptures and its bylaws.
- 4. The local assembly shall have the right to acquire and hold title to property in its own right, either through trustees or in its corporate name as a self-governing assembly.
- 5. All true Pentecostal believers associating themselves in local bodies as assemblies and accepting their full share of responsibility of the maintaining of scriptural order in the local body, shall have a standard for membership that may be determined either by the local assembly itself or by agreement with the Network Council.
- B. Network Council-Affiliated Churches

These assemblies function under the authority and oversight of the Network Board of Directors and are encouraged to proceed to the status of a General Council-Affiliated church.

Section 2. Privileges and Responsibilities Related to Affiliation

A. General Council-Affiliated Churches

The fact that a local assembly is affiliated in the association of the Network and General Council shall in no way destroy its rights as stated nor shall such relationship interfere with its self-government.

B. Network Council-Affiliated Churches

The fact that a local assembly is affiliated with the Network Council shall in no way destroy its rights as stated in the bylaws.

- C. All Affiliated Churches
 - 1. The local assembly shall recognize that the Network or General Council has the right to approve scriptural doctrine and conduct.
 - 2. When in need of counsel or advice, the local assembly may consult with the Network leadership for help.
 - 3. The General Council-affiliated assembly may appeal the decision by the Network leadership to the Executive Presbytery of the General Council of the Assemblies of God when there is a question of whether or not the assembly has received proper help from the Network. When exceptions are taken to the decisions of the executive presbytery, either by the General Council-affiliated assembly or by the Network Board of Directors, appeal may be made to the General Presbytery.
 - 4. Local assemblies are expected to have an interest in the World Ministries of the Assemblies of God and to plan for regular contributions for its support.
 - 5. Local assemblies shall be set in order and cooperate with the Network.
 - 6. Local assemblies shall support the Network organizations and may send delegates to the Network Council.

ARTICLE X. RIGHT OF INITIATIVE

Any active member of the Kansas Network Council (AGK) may exercise the right of initiative to address matters of concern with the Superintendent, Board of Trustees, and the Kansas Network Council provided that member adheres to the process found in the bylaws, Article IX.

ARTICLE XL AMENDMENTS

Amendments to the constitution may be made by a two-thirds majority vote, provided such proposals have been submitted to the Network office for proper editing and publication. The proposed amendment shall be mailed to the membership at least 30 days before a regular business meeting.

KANSAS NETWORK BYLAWS

ARTICLE I. RULES OF ORDER

Section 1. Parliamentary Procedure

In order to expedite the work of the Kansas Network Council of the Assemblies of God Inc., (AGK) and to avoid confusion in its deliberations, the Council shall be governed by *Roberts Rules of Order*, in keeping with the spirit of Christian love and fellowship.

Section 2. Voting Constituency

The voting constituency shall consist of all accredited members present and registered, including:

- A. Certified ministers.
- B. Licensed ministers.
- C. Ordained ministers.
- D. Church delegate Each affiliated or associated church shall be allowed one delegate chosen by local church processes.

Section 3. Quorum

- A. Board of Directors A majority of the members of the Board of Directors responding to a properly called meeting shall constitute a quorum.
- B. Committees A majority of the members of any committee or team responding to a properly called meeting shall constitute a quorum.
- C. Network Meetings All ministers and delegates who shall respond to the announcement of the time and place of a Network meeting, called according to the bylaws, shall constitute a quorum.

Section 4. Order of Business

- A. The regular order of business for the Network Council, unless necessity requires adjustment, shall be:
 - 1. Report of the Roster Committee.
 - 2. Elections interspersed through the remaining agenda.
 - 3. Reports of officers and departments (as needed).
 - 4. Unfinished business.
 - 5. New business.
 - 6. Adjournment.
- B. All business sessions of the Council shall commence with prayer.

ARTICLE II. LEADERS

Section 1. Personnel

- A. Network
 - 1. Board of Directors The Superintendent, Assistant Superintendent, Secretary/Treasurer, and Presbyters shall constitute the Board of Directors, otherwise-known as the Network Presbytery.
 - 2. Trustees The Superintendent, Assistant Superintendent, and Secretary/Treasurer shall constitute the Board of Trustees.
 - 3. Departments and Initiatives
 - a. Departments and other initiatives shall be established, as deemed necessary and beneficial, by proposal of the Network Superintendent and ratification of board of directors. Guidelines and operating procedures for such departments and initiatives shall be included in the Policy and Procedure Manual.

- b. All department directors shall serve at the discretion of the Network Superintendent, with their appointments being ratified by the Network Board of Directors. All such directors shall be selected from the membership of the Network at-large.
- c. Teams working with department director will be selected by the department director and ratified by the Network Superintendent.
- B. General Council, General Presbyters The Superintendent, Secretary and Treasurer shall be general presbyters by virtue of their office.

Section 2. Qualifications

- A. The officers of the Network Council shall be chosen from the membership of the Network Council.
- B. The ministers that comprise the Board of Directors shall be ordained ministers of ability and of mature experience who have a minimum of five years' experience as a credentialed minister, have been resident members of the AGK for at least one year, and have a cooperative and supportive attitude. Such qualifications shall determine their eligibility.
- C. The Board of Directors shall consist of 15 ordained ministers: three executive officers (Superintendent, Assistant Superintendent, Secretary/Treasurer) and 12 regional presbyters consisting of three presbyters per region. (The AGK Policy & Procedure Manual shall delineate the method and details for nomination and election to each post.)
- D. In the event only one, or no minister meets the above qualifications for the office of presbyter in any section, the Network Executives shall be authorized to waive the qualifications, according to guidelines in the Policy and Procedure Manual, Article II. Structure; Section A. Qualifications for Presbyter, in order to provide a slate of nominees for the office.

Section 3. Term of Office

- A. The Superintendent shall be elected to office in even-numbered years and shall begin office on the first day of June of the year of election and continue for four years or until a successor qualifies.
- B. The Assistant Superintendent shall be elected to office in even-numbered years, but generally not in the same year as the Superintendent. The Assistant Superintendent will begin office on the first day of June of the year of election and shall continue for four years or until a successor qualifies.
- C. The Secretary/Treasurer shall be elected to office in even-numbered years, but generally not in the same year as the Superintendent. The Secretary/Treasurer will begin office on the first day of June of the year of election and shall continue for four years or until a successor qualifies.
- D. Presbyters
 - 1. Election to any of the posts as an officer or presbyter shall automatically carry the status of membership on the Board of Directors.
 - 2. The term of office shall be for three years and shall begin one day after their election.
 - 3. All non-executive officer Board Member posts may be filled by the same person for a maximum of two consecutive three-year terms. Following two consecutive terms in any of those posts, she/he will no longer qualify for any of the non-executive officer Board roles. That person will rotate off the Board for at least one year.
 - 4. Each year the council will elect various presbyter positions as defined in the AGK Policy & Procedure Manual to ensure a proper rotation basis.

Section 4. Vacancies

In the event of a vacancy in the Network offices, it shall be filled in the following manner:

- A. Superintendent The Board of Directors, within 10 days, shall call a one-day special Council meeting to be held within 30 days to elect a Superintendent.
- B. Secretary A meeting shall be called in connection with the nearest scheduled Network event, and a Secretary elected.
- C. Treasurer A meeting shall be called in connection with the nearest scheduled Network event, and a Treasurer elected.

- D. Presbyters When a vacancy occurs between Council sessions in any presbyter post, the Superintendent or other Executive Officer, as necessary, shall call a meeting of the AGK Board within 60 days of that vacancy for the Board to nominate and elect a qualified successor to fill the unexpired term of that post. The person thereby elected will fulfill the unexpired term and may then serve two three-year terms in that post, if nominated and then elected by the AGK Network in deliberative session.
 - 1. The Superintendent, in consultation with the available Executive Leadership Team shall convene a regional business meeting, within 60 days of vacancy. In advance, the Network office shall provide a list of all qualified names for the position to the credential holders and churches in the specific region.
 - 2. The exclusive purpose of the special meeting shall center on electing a qualified successor to that specific office to fulfill the unexpired term. Only those eligible voters from the specific region may nominate a candidate.
 - 3. The election shall be open to the eligible voters of the entire Network present at the meeting.
 - 4. The same balloting procedures shall apply as would if the election were occurring at a Network Council.
- E. Any other office for which no specifics have been given regarding vacancies, shall be filled by the Board of Directors.

Section 5. Nominations and Elections

- A. Candidates for Network Superintendent shall be nominated by secret ballot.
- B. A slate of up to three qualified candidates shall be submitted to the Network Council by the Board of Directors for each of the offices of Assistant Superintendent and Secretary/Treasurer. These candidates shall be selected from the Network at-large.
- C. A presbyter shall be nominated through a selection process as defined in the presbyter section of the Policy and Procedure Manual.
- D. The candidate receiving a two-thirds majority vote in the first, second or third electoral ballot shall be declared elected, and if no candidate receives such two-thirds majority by the end of the third electoral ballot, only the two nominees receiving the highest number of votes in the prior ballot shall remain for consideration with all other nominees dropped, and further electoral ballots shall require a simple majority of votes cast to facilitate an election.
- E. The Superintendent, Assistant Superintendent, Secretary/Treasurer, and regional presbyters shall be elected at one of the official meetings of the Network Council.

Section 6. Notification, Network Board of Directors

All meetings of the Network Board shall occur as stated in the Policy and Procedure Manual.

Section 7. Courtesy of the Floor

The courtesy of the floor shall be extended to visiting ministers from other Networks of the Assemblies of God; the right to vote shall be withheld.

ARTICLE III. DUTIES OF THE LEADERS

Section 1. Superintendent

- A. To preside at meetings of the Network Council.
- B. To be the head of the Network office, and to supervise the work of that office during the interim between sessions of the Network Council.
- C. To call and to preside at all the meetings of the Board of Directors and to receive all communications addressed to that body.
- D. To administer discipline in all cases when requested to do so by the Board of Directors.
- E. To act as president of the corporation.
- F. To serve as a general presbyter by virtue of his office.
- G. To be an ex-officio member of all teams and committees.

- H. To be the personnel director of all AGK employees.
- I. To perform any other function usual and customary for the presiding officer, or as may be directed by the Network Council or the Board of Directors.

Section 2. Assistant Superintendent

- A. To serve as an assistant to the Network Superintendent in every possible way, and to preside in an official capacity in place of the Superintendent as the occasion demands.
- B. To act as Vice-President of the corporation.
- C. To serve as a General Presbyter by virtue of office.
- D. To carry such portfolio assignments as directed by the Superintendent, Network Council, or the Board of Directors.

Section 3. Secretary/Treasurer

- A. To keep a true record of the proceedings of the Network Council meetings, also the meeting of the Board Directors, Board of Trustees, and the Credentials Interview Team.
- B. To serve as custodian of the seal of the Network Council.
- C. To preside over the Credentials Interview Team in session.
- D. To issue credentials under the direction of the General Council Credentials Committee and the Network Board of Directors.
- E. To keep a record of all ministers and churches in the Network.
- F. To see that all monies received by the Network Council and its departments are disbursed properly.
- G. To serve as resident agent of the corporation and as chairman of the Budget Team.
- H. To establish and maintain a reliable system of bookkeeping and to provide regular financial reports to the Board of Directors.
- I. To serve as Secretary/Treasurer of the corporation in legal matters.
- J. To serve as general presbyter by virtue of office.
- K. To serve as Treasurer to all Departments of the AGK.
- L. To perform any other functions usual and customary for a Secretary/Treasurer or as may be directed by the Superintendent, Network Council, or the Board of Directors.

Section 4. Board of Directors

- A. To have the general oversight of the activities of the Network during interim between Council sessions.
- B. To act for the Network in all emergency matters that affect its interests and to execute its decisions.
- C. To arrange for its own meetings, a minimum of one per quarter. All decisions made in those meetings shall be final unless reversed by the Council in session.
- D. To take the necessary legal steps in the transfer of church property, title, and monies to the Kansas Network Council of the Assemblies of God Inc., (AGK) under the following provisions, when it does not infringe on the self-governance of the local church:
 - 1. In the event the church property should cease to be used as an Assemblies of God church.
 - 2. In the event said congregation should sever its affiliation with the Kansas Network Council of the Assemblies of God Inc., (AGK) or the General Council of the Assemblies of God Inc.
 - 3. When a church has ceased to operate as a local assembly.
 - 4. When a church has solicited and collected money in the name of the Assemblies of God, local, Network or otherwise.
- E. To serve as the Network Credentials Committee in the recommending of credentials, administering discipline and reviewing applications for reinstatement and renewal of ministerial credentials.
- F. To set the salary and remuneration of all Network employees.
- G. To supervise the distribution of funds in consultation with the department director or leader in charge of the activity for which the fund is used.
- H. To ratify the following:
 - 1. The establishment of any or all departments or initiatives proposed by the Network Superintendent.
 - 2. All department directors or ministry coordinators appointed by the Network Superintendent.

- I. Division of Primary Responsibilities of Board Members
 - 1. State-wide Level
 - a. Advance the AGK purpose to strengthen and establish effective Pentecostal leaders and churches.
 - b. Advance the mission of the AGK which is to promulgate the full gospel message throughout Kansas, the region and the world, and to conserve our work through elevating the pursuit of health within established AGK churches.
 - c. Provide advice and input to the Superintendent and full Board of Directors regarding the appointment or reappointment of a pastor serving a Network Council level church.
 - d. Act as the official board of all Network Council level churches in matters as described in the Network Policy and Procedure Manual.
 - e. Assist as needed or requested by Network Leadership to arbitrate issues of confusion and or conflict in congregations of local churches within the region or as requested to assist in another region.
 - f. Participate with church planting initiatives by providing advice and input on church plants in their region if that plant is not directly associated with a parent church (act as a coordinating agent if it is associated with a parent church.)
 - g. Act as an encourager, protector and supporter to any lead pastor planting a church in the region (daughter, satellite, Parent Affiliated Church, etc.)
 - h. Assist as a key arbitrator and peacemaker in any case of concern between an existing church and a planter or a planting church initiating a work perceived as infringing on the work of an existing church.
 - i. Maintain a predisposition for encouraging the establishment of new churches in the region and only resisting such plants for unequivocal Kingdom reasons.
 - 2. Local / Regional Level
 - a. Partner with others and work personally to establish multiple new healthy AGK churches through various methods and models.
 - b. Provide wise counsel, advice, ministry assistance and support to ministers and church boards as requested or required from local leadership or from (Network Council) network leadership directive.
 - c. Provide relational supervision and support of pastors serving Network Council level churches through mentoring, coaching, consultation, instruction and as further delineated in the Network Policy and Procedure Manual.

Section 5. Trustees

- A. The Superintendent, Assistant Superintendent, and Secretary/Treasurer shall constitute a Board of Trustees who provide for the safekeeping of all the property of the Kansas Network Council of the Assemblies of God Inc., (AGK) both real and chattel.
- B. They shall sign, execute and deliver, in the name and on behalf of the corporation, all legal documents and the Secretary/Treasurer shall certify in such instruments of conveyance that the same has been duly recommended and authorized.
- C. The trustees shall purchase or sell property of the corporation real or chattel, only by the authorization of at least a two-thirds vote of the Board of Directors.
- D. They shall act in emergency matters affecting the Network in the interim between meetings of the Board of Directors.

Section 6. Presbyters

See Kansas Network Policy and Procedure Manual.

ARTICLE IV. DEPARTMENTS

Section 1. Network Policy and Procedure Manual

- A. Each department created and established shall be governed by the Network Policy and Procedure Manual.
- B. The Policy and Procedure Manual shall:
 - 1. Be consistent with the prerogatives and purposes of the Kansas Network Council as set forth in the constitution and bylaws.
 - 2. Define departmental parameters and the administration of departmental efforts.
 - 3. Set forth the qualifications for and duties of departmental leaders.
 - 4. Provide guidelines for departmental financing.
 - 5. Be under the close oversight and supervision of the Network Superintendent and Board of Directors who shall be empowered to approve or improve any policy for the expansion of the Kingdom of God.

Section 2. Amenability

The departments and ministry initiatives shall be amenable to the Network Council and its leaders.

ARTICLE V. FINANCES

Section 1. Supervision

- A. All finances shall be under the immediate supervision of the Board of Directors.
- B. Funds associated with various departments of the Network shall be disbursed in consultation with the department director or Executive in charge of the activity for which the fund is used.

Section 2. Types of Income

A. Tithes

- 1. Ordained ministers to pay \$25 per month to the General Council office, the balance of ministry income tithe to the Kansas Network Council.
- 2. Licensed ministers to pay \$20 per month to the General Council office, the balance of ministry income tithe to the Kansas Network Council.
- 3. Certified ministers to pay \$10 per month to the General Council office, the balance of ministry income tithe to the Kansas Network Council.
- 4. Ministers who are eligible to vote and engaged in secular work are to send one-fourth of tithes from secular work to the Kansas Network Council. An exemption of the one-fourth tithe is given to ministers serving as pastors of churches with 50 or less in average weekend attendance.
- 5. The annual contribution to the General Council for each credential level may be deducted from the giving listed above.
- 6. Evangelists are to send one-half of their tithes to the Network in which they are working and an equal share to their home Network. It is recommended that the same cooperation be given by evangelists working in Kansas.

B. Churches

It is recommended that local churches financially participate in supporting Network projects and missions efforts both world and domestic.

Section 3. Burial Fund

- A. In the event of the death of a minister of the Kansas Network Council or a minister's spouse or dependent children, a \$300 gift shall be sent to the surviving spouse, the monies to be taken from the Network Development Department.
- B. Ministers who wish may contribute toward this expense.

C. As soon as the Network office receives the information, a notice shall be sent to all ministers in the Network so that condolences may be made.

ARTICLE VI. GEOGRAPHIC STRUCTURE

Section 1. Structure

- A. The AGK structures itself as four geographic regions within the state of Kansas. These four shall be called the West Region, Central Region, Northeast and Southeast Region.
- B. The regions exist within the following lines and highway locations:
 - 1. West: Colorado state line east, including towns directly interacting with N-S Highway 281.
 - 2. Central: East of N-S Highway 281 and including towns directly interacting with N-S Highway 77.
 - 3. Northeast: From N-S Highway 77 east to the Missouri state line, including towns directly interacting with or north of Kansas State Highways 56, 31, 268, and 68.
 - 4. Southeast: From N-S Highway 77 east to the Missouri state line, including towns south of but not directly interacting with Kansas State Highways 56, 31, 268, and 68.

Section 2. Purpose

The regions exist to:

- 1. Affirm the statewide focus of the AGK Ministry Network while encompassing the variety of perspectives represented in any given region
- 2. Provide organizational focus for enhancing church health and multiplication
- 3. Provide a broad base from which to discover capable leaders to serve on the governing Board of Directors
- **4.** Provide geographical connection points for strategic events applicable to large numbers of ministers and or churches

ARTICLE VII. THE MINISTRY

Section 1. Definition

We classify ministers in three progressive areas of recognition, as follows:

- 1. Certified Ministers
- 2. Licensed Ministers
- 3. Ordained Ministers

We also recognize a Local Church Credential as described in General Council bylaw Article VII Ministry.

Section 2. Qualifications

All candidates for ministerial recognition, men and women, must give evidence of:

- 1. A born-again experience (John 3:3).
- 2. The baptism in the Holy Spirit (Acts 2:4) and a Spirit-filled life (Eph. 5:18).
- 3. A divine call to the ministry (1 Tim. 3:1-7 and Titus 1:7) and meet all the requirements outlined by the General Council of the Assemblies of God and Kansas Network Assemblies of God as stated in the Kansas Network Policy and Procedure Manual.

Section 3. Procedures for Securing Credentials

See Kansas Network Policy and Procedure Manual.

Section 4. Annual Fellowship Certificates

All credentials expire annually and issuance of fellowship certificates is subject to the approval of the Network Board of Directors upon receiving a completed renewal form and on meeting the renewal conditions for the specific credential level as outlined in the Kansas Network Policy and Procedure Manual.

Section 5. Termination of Credentials

- A. On the initiative of the minister A minister may elect to terminate his credentials and be listed as follows if he or she meets the requirements as listed in the Kansas Network Policy and Procedure Manual.
 - 1. Lapsed
 - 2. Resigned
- B. On the initiative of the Network A minister may have his or her credential terminated and listed as follows if he or she falls under the conditions listed in the Kansas Network Policy and Procedure Manual.
 - 1. Suspended
 - 2. Inactive
 - 3. Not renewed
 - 4. Dismissed

Section 6. Trials and Appeals

Any minister charged with willful violation of Council principles, wrong doctrines or other misconduct shall have the right of a fair trial in accordance with Council principles, as defined and interpreted by the General Council Bylaws, Article X

Section 7. Restoration of Credentials

- A. Renewed The term "renewed" shall apply to all ministers who have met the annual deadline for renewal including those who are delinquent but who renew by January 15.
- B. Reinstated The term "reinstated" shall apply to those whose names have been deleted from the official ministerial list, who upon application are approved for restoration of credentials.

Section 8. Ministerial Ethics

- A. To the Network Council
 - 1. All ministers shall be amenable to the Network Council in matters of doctrine and conduct.
 - 2. All ministers shall be expected to affiliate with the Network Council and to work and cooperate with the same, and failure to do so shall bring their ministry into question.
 - 3. Ministers must renew their credentials annually, within the specified time, in order to maintain affiliation with the Kansas Network Council and/or the General Council of the Assemblies of God.
 - 4. Ministers shall refrain from identifying themselves with any of the secret orders.
 - 5. Ministers shall not perform a marriage ceremony for anyone who has been divorced and whose former companion is still living (unless his case is included in the exceptional circumstances described in the General Council Bylaws, Article IX, Section 5, Letter b.). Any minister of our fellowship who performs such a ceremony, unless he is innocently deceived into doing the same, may be dismissed from the Council.
 - 6. Ministers using their personal finances in church building projects, without the approval of the Board of Directors, shall have no recourse to any refund. The Network will not assume responsibility in such cases.
 - 7. The Board of Directors shall be empowered to discipline unruly members in accordance with the Scriptures and in keeping with the resolutions passed by the General Council affecting such matters.
- B. To the Church
 - 1. Ministers shall endeavor to safeguard the church from unreliable and unsafe teachers who seek entry into the assemblies without proper identification and recommendation.
 - 2. Ministers shall refrain from accepting tithes from assemblies or local members where they formerly had charge.
 - 3. Ministers are not to accept an office in the church of which they become a member unless this restriction is waived by the Network Board of Directors.

- 4. All correspondence that concerns the whole assembly shall be addressed to the one in charge and not to private members. When there is no pastor, letters concerning the work shall be addressed to the officers of the assembly.
- 5. Inasmuch as unity is a vital principle for growth and spiritual development of the church, it is essential that we recognize our vital relationship to each other, and that we practice Christian cooperation in all our pastoral, evangelistic, missionary and local church work and business. Therefore, we urge that our ministers consult with our Council officials before engaging in ministry with non-Council assemblies in any given area of the Network, so as to ascertain whether or not such non-Council assembly is approved as to doctrinal standards and cooperative fellowship with Council assemblies, and if not approved by the Network officials, they shall be expected to refrain from conducting services for them. Ministers who violate this principle shall be considered as having opened the door for censure or charge, which may necessitate the recall of their credentials.

C. To Other Ministers

- 1. All discourteous conduct is disapproved, and all ministers are advised against interfering with pastors in charge of assemblies whether it be by going in upon their work without consent or by such correspondence with members of the congregation as will hurt the influence of the pastor.
- 2. Any minister who so offends shall be subjected to scriptural treatment as an offender by the Network officiary or by the executive presbyters of the General Council. Such discourtesy will seriously affect the granting of annual fellowship certificates and may be the basis for their recall.

Section 9. Transfers

- A. Church Membership
 - 1. To avoid confusion among the assemblies in the Network, before members of one assembly are received into fellowship of another assembly, it is strongly recommended that the pastors involved consult with each other relative to a letter of transfer.
 - 2. In the event that charges are pending against any of these persons, a satisfactory solution should be sought before these people are transferred or accepted into membership.
 - 3. Under no conditions shall any persons be accepted into the membership in another church until their membership in the first church has been officially terminated.
- B. Into the Network A minister who moves into the Network, with the intent of making that his or her place of residence, shall file with the Network Secretary/Treasurer a letter of transfer from his or her former Network within 60 days.
- C. Out of the Network
 - 1. When a minister leaves the Network, he or she shall inform the Network Secretary/Treasurer of such removal, giving a forwarding address where he or she may be reached if necessary.
 - 2. If the minister leaves the Network for permanent ministry in some other Network, a letter of transfer shall be sent within a 30-day period to the Secretary/Treasurer of the new Network.
 - 3. Exceptions regarding transfer of credentials may be made for ministers who are:
 - a. Moving to serve at General Council National Office
 - b. Retired from active ministry.
 - c. In the armed forces currently on active duty.
 - d. Serving on the faculties of schools affiliated with the General Council and Network Council or nonaffiliated schools acceptable to the General Council and the Network in which the school is located.
 - e. Appointed world missionaries retaining membership in their home Network.
 - f. Students in schools outside their home Networks.
 - g. Serving in a non-Assemblies of God institution providing:
 - (1) They have a regular scope of ministry which reaches beyond Network boundaries.
 - (2) Both Networks agree to the exception.
 - (3) The institution is acceptable to both Networks.

Section 10. Rites and Ordinances of the Church

- A. Any minister who is either ordained, licensed, or a certified minister who is a pastor, shall have the right to perform the rituals of the church, which include:
 - 1. The communion service.
 - 2. Water baptism.
 - 3. Dedication of infants.
 - 4. Marriage ceremonies.
 - 5. Funeral services.
- B. The above-listed rituals shall be considered an active part of the ministry.

ARTICLE VIII LOCAL ASSEMBLIES

Section 1. Self-Governing Assemblies

- A. Obligations of Affiliation
 - 1. Assemblies must recognize their obligations to the fellowship as a whole and to maintain proper standards of doctrine, church order and conduct.
 - 2. Assemblies shall strive to maintain doctrinal unity and practice by refusing to call as pastor anyone who does not hold or maintain credentials with the Assemblies of God or who has not been approved by the Network.
 - 3. They shall be expected to participate in the cooperative program of the General and Network Councils for the propagation of our testimony in both the U.S. and world contexts and to share in such provisions as may be made for the maintenance of the fellowship on financial or other practical lines.

B. Requirements

- 1. General Council-Affiliated Churches Article XI Section 1, (a) of the General Council Constitution states that the requirements for General Council-affiliated churches are as follows: They shall
 - a. Accept the tenets of faith of the Assemblies of God
 - b. Adopt a standard of membership that may be determined either by the local assembly or by agreement with the Network Council;
 - c. Have a minimum active voting membership of 20 persons who shall accept responsibility to maintain scriptural order in the local body;
 - d. Adopt a constitution or bylaws compatible with those recommended by the Network Council;
 - e. Have an adequate number of spiritually qualified members to fill the offices of the church called for in its constitution or bylaws, and
 - f. Make provision for a pastor who is a credentialed minister in good standing with the General Council and Network Council.
- 2. Reversion to Network Council-Affiliated Status
 - If a General Council-Affiliated church is unable to meet any of the criteria for affiliation, as set forth in the General Council Constitution, Article XI, Section 1, paragraph a, it shall seek the assistance of the Network executives for help in maintaining the minimal requirement for General Council affiliation. The executives may use any means prescribed by the bylaws to assist the church in returning to a position of strength. If, after one year, the minimal requirements have not been attained, the church shall revert to Network-affiliated status until the minimal requirements for General Council affiliation have been attained.
- 3. Network Council-Affiliated Churches
 - a. Churches that do not meet and/or maintain the minimal requirements for General Council-Affiliated assemblies shall be recognized as Network Council-Affiliated churches of the Assemblies of God.
 - b. The Board of Directors shall give guidance to Network Council-Affiliated Churches under the guidelines set forth in the Policy and Procedure Manual for Network Council-Affiliated

- Churches. This Policy and Procedure Manual shall be developed, maintained and approved by the Board of Directors.
- c. All newly formed Assemblies of God churches in Kansas shall be governed by the Official Bylaws for Network Council-Affiliated churches, as set forth in the Policy and Procedure Manual, until such time as they meet the minimal requirements for General Council-Affiliated assemblies.
- d. Established Network Council-Affiliated Churches may continue to function under their present Constitution and Bylaws as approved by the Network Board of Directors.
- e. The church may come under Network supervision at the discretion of the Superintendent and Presbyter should the need arise:
 - (1) by request of the pastor,
 - (2) by request of a majority of the church pastoral support team
 - (3) by petition of the majority of the voting membership of the church,
 - (4) by unresolved conflict between any of the above, as determined by the Superintendent and Presbyter
 - (5) or by failure to follow Network guidelines for Network-Affiliated Churches in the Policy and Procedure Manual.
- 4. The supervised assembly shall be governed by the Official Bylaws for Network Council-Affiliated churches, as set forth in the Policy and Procedure Manual. Before such a decision is made the local pastor and church pastoral support team shall have the right to confer with the Board of Directors. Network supervision may continue until such time as the issues of the Assembly shall be resolved as determined by the Board of Directors. Any Constitution and Bylaws the church may have will be set aside for the time of Network supervision and function under the Network Council Affiliated bylaws.

Section 2. New Assemblies

The Board of Directors shall supervise new assemblies under the guidelines set forth in the Kansas Network Policy and Procedure Manual.

Section 3. Church Property

- A. Location Recommendations are provided in the Kansas Network Policy and Procedure Manual.
- B. Deeds Recommendations are provided in the Kansas Network Policy and Procedure Manual.

Section 4. Financial Assistance

Recommendations are provided in the Kansas Network Policy and Procedure Manual.

ARTICLE IX. RIGHT OF INITIATIVE

Exercising this right of initiative requires sequential observance of the following three sections (following the principles of Matthew 18).

Section 1. Presentation to Superintendent

Any active member of the Kansas Network Council may formally express matters of concern to the Network Superintendent by requesting a private meeting with the Superintendent and providing written communication to the Superintendent of the matter of concern.

Section 2. Presentation to Board of Trustees

Any three members of the Kansas Network Council may together formally express matters of concern to the Board of Trustees by requesting a meeting with the Board of Trustees and providing written communication of the matter of concern. This meeting may be requested provided at least one such member has followed the process established by Article IX Section 1.

Section 3. Presentation to Network Council

Any active member may exercise the right of initiative in the calling of a special meeting of the Kansas Network Council by presenting a request signed by no fewer than fifty active members of the council provided the matter has first been presented according to the process established by Article IX, Sections 1 and 2. The request shall be presented to the Superintendent or Secretary of the Network, who shall proceed to issue a call for said meeting as prescribed in Article VII, Section 2, of the Constitution.

ARTICLE X. AMENDMENTS

All proposed amendments to the bylaws shall be presented to the Network Council in typed form, such proposal showing both the present reading and the proposed amendment.

ARTICLE XI. ADDENDA

All matters not covered by the constitution and bylaws or by resolutions that have been passed by the Network Council shall be governed by resolutions appearing in the minutes of the General Council of the Assemblies of God, "endeavoring to keep the unity of the Spirit in the bond of peace, until we all come to the unity of the faith."
